APPLICATION INFORMATION

The Organizational Affiliate level of membership is for groups of individuals within a common organization. Levels are arranged both by the groups' for profit or non-profit status as well as the number of people that the group would like to include in its ACR membership (not the total number of employees at the organization).

Level One: Includes 1-5 members. This membership allows up to five persons to have online member profiles. The group receives five magazine subscriptions, one journal subscription, two discounted Annual Conference registrations, and various product discounts.

Level Two: Includes 6-9 members. This membership allows up to nine persons to have online member profiles. The group receives nine magazine subscriptions, two journal subscriptions, four discounted Annual Conference registrations, and various product discounts.

Level Three: Includes 10-15 members. This membership allows up to 15 persons to have online member profiles. The group receives fifteen magazine subscriptions, four journal subscriptions, eight discounted Annual Conference registrations, and various product discounts.
